DEFINITIONS

CONSIDERATION: Payment or Service provided to the subject or representative.

DISTRIBUTION: The act of providing electronic or printed copies of photographs without charge to the recipient. Distribution Rights allows Promotional use.

FAMILY: Group of persons related by blood, marriage, adoption, or legal guardianship.

GROUP: Gathering of persons by coincidence or organized in assembly.

MINOR: Any person under the age of 18.

PERSONAL USE: The act of printing for own use or gifts to immediate family members without charge; also includes display on personal web site and personal computer without profit or promotion.

PROMOTIONAL: The act of using photographs in advertising, brochures, web-sites, and other promotional materials without charge.

PUBLISH: Reproduce (copy) photographs usually in print or internet.

ROYALTY: A fee provided for each image copy distributed for profit or promotional use.

TRADE: The act of selling electronic or printed copies of images at a charge for profit.

PARENTAL/GUARDIAN CONSENT

The parent or legal guardian of the minor model must produce legal identification showing name and address supporting responsibility of the minor. The parent/guardian should read this entire release and agree to its terms before the photography session begins.

One parent/guardian may be present for observation at each photography sessions, at their will, provided they do not disturb the model, photographer or staff members.

LIABILITY LIMITATION

The subject person(s) and any guests travel to and from session locations at their own risk. Shutter Fantasies Photography, its associations and affiliates, legal representatives, assigns and licensees are not liable for accidental injury or death, or incidental personal loss resulting from transport or participation in the photography event.
